Important Notice to Applicant

- If you need any accommodation or help with this process, please let a staff person know. For example, you have the right to have a support person like an Elder, Native Inmate Liaison Officer (NILO), Community Corrections Worker (CCW), interpreter, mental health worker, etc. to fill out this form or when you appear before the Board.
- You have the right to appear before the Board for a parole hearing if you are serving a sentence of six months or more.
- There are two options available to you for parole consideration:



Option 1: Choosing to Waive Parole Hearing:

- If you choose to give up your right to a hearing, it means that you are giving up your right to tell the Board, in person, why you do or do not want to be released on parole.
- Once the Board has made its decision, it will send you a copy of its decision by mail.
- If you are granted parole, the ILO will meet with you to review the Board's decision and the Parole Decision Information Sheet for Applicants and a Request for Parole Revocation Prior to Release Form.
- If you are granted parole and do not want to be released, you will need to complete a *Request for Parole Revocation Prior to Release Form* and submit it to the Board through the ILO.
- You may change your mind at any time before the Board makes a decision by notifying the Board in writing through the ILO. Upon receipt of the withdrawal of your waiver, the Board will proceed on a reasonable timeline to consider you for parole.

Option 2: Choosing to Waive Parole Consideration:

- If you change your mind you may withdraw ("rescind") your waiver at any time by notifying the Board in writing through the ILO. Upon receipt of the withdrawal of your waiver, the Board will proceed on a reasonable timeline to consider you for parole.
