According to section 42(1) of Regulation 778 under the *Ministry of Correctional Services Act* R.R.O. 1990 (Regulation), where an inmate is serving a term of imprisonment of less than six months, the inmate may apply to the Ontario Parole Board for parole at any time.

According to section 42(2) of the Regulation, an inmate referred to in section 42(1) is not entitled to a hearing of the Board and therefore must make an application.
